The CrowdBureau® P2P Online Lending and Digital Banking Index (CBLENDT) rose +0.16% on Tuesday, June 15, 2021, to end with a value of 100.39. All three major U.S. benchmarks closed with losses. The Dow Jones Industrial Average (DJIA) declined -0.27% or -94.42 points to register at 34,299.33. The S&P 500 index (SPX) fell -0.20% or -8.56 points, to close at 4,246.59. The Nasdaq Composite (COMP) decreased -0.71% or 101.29 points, to finish at 14,072.86. The Russell 200 index (RUT) that tracks small cap stocks slid -0.26% or -6.07 points to record lower at 2,320.07. The yield for the 10-year Treasury note TMUBMUSD10Y, yielded 1.498%, remaining nearly flat from the prior day.

- 1. Fifty percent (24) of the 48 CBLENDT index constituents share prices advanced on Tuesday, June 15, 2021, with performance ranging from -8.99% to +6.91%.
- 2. Upstart Holdings (UPST) stock dropped 1.3% following the expiration of the lockup period for some of its shares.
- 3. OneMain Holdings, Inc. (OMF) added +1.40% announced that its direct, wholly-owned subsidiary OneMain Finance Corporation ("OMFC") priced \$750 million aggregate principal amount of its 3.500% senior notes due 2027 (the "2027 notes") in connection with its previously announced registered notes offering. The size of the notes offering has been upsized from \$500 million to \$750 million.
- 4. X Financial (XYF) +0.61%, a China-based an online personal finance company, released unaudited financial results for the first quarter ended March 31, 2021. Total net revenue in the first quarter of 2021 endedRMB906.3 million (US\$138.3 million), representing growth of 71.3% from RMB529.0 million in the same period of 2020. Income from operations in the first quarter of 2021 rose RMB251.2 million (US\$38.3 million), compared with loss from operations of RMB130.0 million in the same period of 2020.
